



EBONYI STATE PROPERTY REGISTRATION GUIDELINE (INDIVIDUAL, CORPORATE AND GOVERNMENT) AND PROCEDURES FOR OBTAINING CERTIFICATE OF OCCUPANCY (C OF O)

In accordance with the provisions of Ebonyi State Government Law and other matters connected to issuance of certificate of occupancy, the procedures are as follows;

1. Obtain the statutory right of application form for private individual and corporate application forms at Ministry of Land and Survey

APPLICATION FORMS REQUIREMENTS:

Applicants are expected to come with the following documents for Application for C of O:

- a) Personal Data Form
 - b) Details of Previous Registration
 - c) Other Requirements
 - i. Submission of original Survey plan
 - ii. Submission of photocopy of document (Power of Attorney, Deed of Conveyance, Agreement. Etc.)
 - iii. Current Tax Clearance Certificate
 - iv. Recent Passport photograph
2. Inspection by Town Planning Officer to give town planning opinion (If any especially if there are encumbrances)Director Town Planning, Phone Number: 08035495936
 3. The survey unit of the Ministry of Land and Survey would check the survey plan as provided by the applicant to see if it is in order as stipulated in the accepted template. (Office of the Survey General, Phone Number: 08032311006)

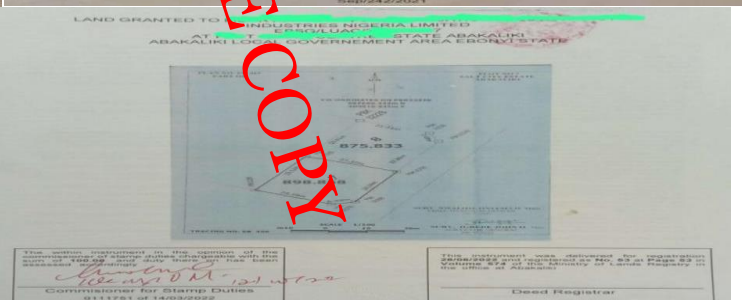
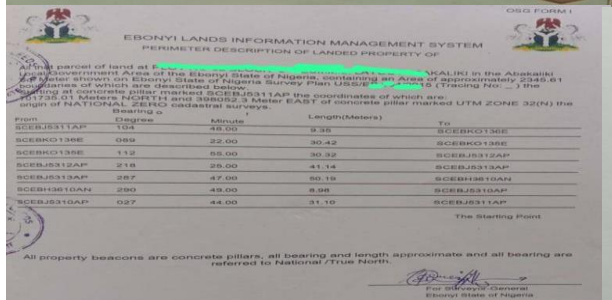
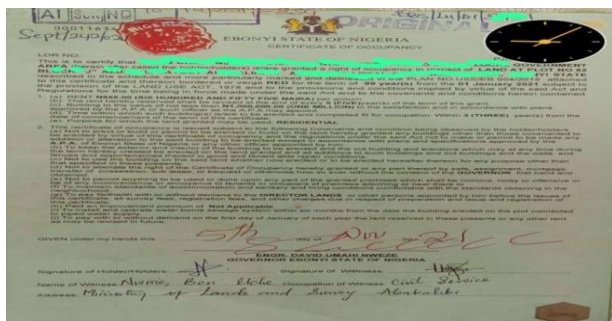

Time Frame

- a) Filling and Submission of application form is dependent on the applicant.
- b) Processing time frames:
 - i. Inspection ----- 1hr
 - ii. Survey check & Charting ----- 20mins
 - iii. The time frame for Payment is dependent on the Applicant's readiness
- 5. The payment invoice is raised by the Ebonyi State Internal Revenue Service using <https://tax.ebsirb.eb.gov.ng/public/payment>
- 6. Applicant can make payment to any of the Commercial Banks.
- 7. Applicant is expected to bring the teller to the Accounts Department under Ministry of Land and Survey where the teller will be changed to Receipt. (HOD Accounts, Phone Number: 08030886822)
- 8. The applicant submits photocopy of the payment receipt to Ministry of Land and Survey (Time frame: Dependent on the applicant, then capturing follows).
- 9. Data Capturing and Printing of C of Os

Time Frame: 30minute

- 10. Governor's Consent /Signatory (Governor evidence of approval for issuance of C of O)



Time Frame: Within a week

11. Stamping at Ministry of Finance and Economic Development

Time Frame: 2Hrs

12. Registration by Lands & Survey

Time Frame: 2 days

13. Dispatch/Collection by Holder

Time Frame: Dependent on the Holder

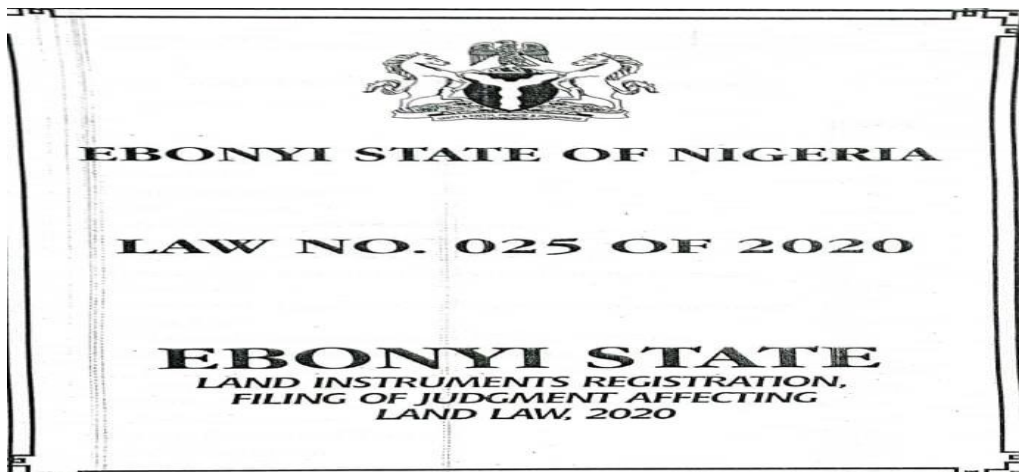
